Instructions to the candidates

1. Courses offered:

2. Eligibility criteria for 5 Year programmes: Admission into Five Year BA.LLB (Hons) and B.B.A.,LL.B (Hons) is based on LSAT-2019 / CLAT-2019 / should have passed Higher Secondary School Examination / Intermediate Examination (10+2) or its equivalent examination not less than **45% marks in aggregate (40% in case of SC / ST and persons with disability)**. Candidates awaiting results may also apply for the course. The age of the candidate should not be more than **20 years** in case of general category and 22 years in case of SC / ST and persons with disability.

3. Eligibility criteria for 3 Year programme: The Candidate should have passed graduation in any discipline (except B.F.A & Single sitting graduates from any distance mode education) with not less than **45% marks (40% in case of SC / ST and persons with disability)** and candidates awaiting results may also apply for the course.

4. Eligibility criteria for 1 Year LL.M in (1) IPR & Cyber Law and (2) Corporate Law: The Candidate should have passed Graduation in Law (LL.B / BA.LLB / BBA.LLB / BSc.LLB / B.Com.LLB) from any recognized University with not less than **50% marks (45% in case of SC / ST and persons with disability)** and candidates awaiting results may also apply for the course. No upper age limit is prescribed for these programmes.

5. Eligibility criteria for 1 Year Diploma Programmes: The Candidate should have passed graduation in any discipline with not less than **45% marks (40% in case of SC / ST and persons with disability)** and candidates awaiting results may also apply for the course. No upper age limit is prescribed for these programmes.

6. Details of Admission Schedule:

- Last date for receipt of filled-in applications : 29th June 2019
- Date of counseling / admissions : 22nd to 24th July 2019
- Commencement of class work (First Year) : 29th July, 2019

7. How to apply: Applications can be downloaded from www.gitam.edu and filled-in applications along with copies of certificates and **DD for Rs.700/- (for girls Rs.500/-)** drawn in favour of the **Director, School of Law, GITAM University** on any scheduled bank **payable at Visakhapatnam**, should be sent to the Director, School of Law, GITAM Deemed to be University, Rushikonda, Visakhapatnam-45, A.P. on or before **29th June 2019.**

- Intermediate / 10+2 certificate in the case of candidates appearing for 5 Year programmes.
- Copy of Transfer Certificate / Study / Conduct Certificate / Date of Birth Certificate (SSC / ICSE / CBSE).
- Copy of Caste Certificate issued by appropriate authority for claiming reservation under SC / ST.
- Copy of Medical Certificate issued by appropriate authority for claiming under PH category.
- Copy of Rank Card of CLAT / LSAT-India or any other All India Admission Test.
